### Section 3 - Hazards Identification

#### **EMERGENCY OVERVIEW**

Appearance: white to almost white crystalline powder.

**Danger!** Risk of explosion if heated under confinement. Flammable solid. Irritant. Causes eye, skin, and respiratory tract irritation.
