SECTION 4: First-Aid Measures

4.1. General First Aid Information

6.2. Cleanup and Containment Methods and Materials

Remove all sources of ignition. Cover spill with a 1:1:1 mixture of Sodium Carbonate or Calcium Carbonate, Clay, and sand. Transport to a fume hood for evaporation. Do not flush to sewer. After evaporation, place in non-halogenated solvent disposal container for recycling or disposal by burning. Ventilate area of spill. Have extinguishing agent available in case of fire. Use non-sparking tools and equipment. Dispose of in accordance with local regulations.

7.1. Precautions for Safe Handling and Storage Conditions

As with all chemicals, wash hands thoroughly after handling. Avoid contact with eyes and skin. Protect from freezing and physical damage. Store in secure, flammable storage area away from all sources of ignition. Empty containers may be hazardous since they retain product residues.

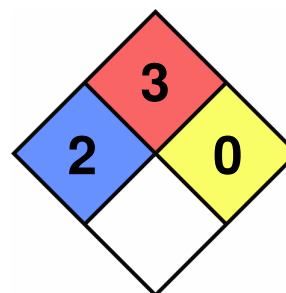
