As with most organic solids, fire is possible at elevated temperatures or by contact with an ignition source. Mannitol: Flash Point: > 149C (300F), Minimum dust cloud ignition temperature: 460C (860F). Fine dust dispersed in air in sufficient concentrations, and in the presence of an ignition source is a potential dust explosion hazard. Mannitol: Minimum explosible concentration = 0.065 g/l Maximum explosion pressure: 97 lb/sq. in.

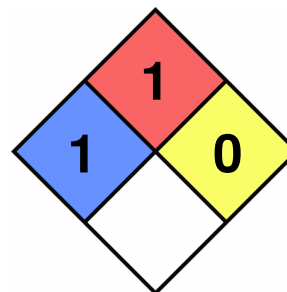
